- Parties may only be scheduled Monday-Thursday before 1pm or after 5:30 pm, or Friday-Sunday before 12 noon and after 5:30 pm.
- A lifeguard must be hired for all pool parties at a rate of \$20/hour for each hour of the party.
- Hosting a party does not exclude club members from being allowed to use the club facilities.

Memberships

There seems to be some confusion as to what to do when you no longer want your membership. Here is some clarification.

It is not up to the Club to sell your membership for you. There are only 100 family memberships. That means each family owns 1/100 of the club equally. Additionally, each family membership is legally responsible for making payments on their dues until they sell or transfer their membership.

Members are free to sell or give away their membership at any time and for any price. When selling their homes, members often transfer their memberships to the new homeowner. This is perfectly within their rights of ownership, however, the CFCC board member in charge of memberships needs to be notified so that the proper transfer paperwork can be completed.

The Club Board members can offer the assistance of current market price, (which to date is about \$550) and if we have a list of buyers, we will happily share that information with you. Unfortunately, at this time there is not a waiting list of buyers, however, there are several members who would like to sell

Some suggestions for selling/transferring your membership; ask friends, family or neighbors if they are interested. People at work, through school, sports or other organizations there may be someone who would buy it from you. You can even try placing an ad on Craig's List or ??

When you do find a buyer, you need to contact the club so that we can collect your key, collect any outstanding payment and process the necessary paperwork transferring ownership to the new member.
