## **Summertime 2009 is Finally Here!**

Despite a few glitches, we have re-keyed the Club. We added some locks on gates and on the BBQ. Please lock these, after you opened and finished using them. Also, the lock on the main gate should be locked to the large, Fire Department lock (it's labeled). This creates a chain of locks and enables either SCE or the Fire Dept. access. The gate has been left open on several occasions recently. Please lock the gate, if you are last one out. If kids are playing on the court, ask them whether they have a key and remind them that the gate needs to be closed. If you had purchased a second key and still have both, please mail both back and we will send you a replacement for your second key.

A courtesy reminder about parties: the Club considers a party any time one member brings more than five guests to the Club. This is particularly relevant to the pool. Parties need to be approved by Vicki Schuster. The reason for this is to ensure that two parties don't conflict. Parties can be scheduled before or after regular pool hours (<12:00 or >5:00). Last year, we experimented with allowing a couple of parties during weekday regular Club hours (pre Summer). It didn't work. Too many unsuspecting members found themselves amidst many enthusiastic kids. And lastly, an approved party only establishes that nobody else can have a party at that time; it does not prohibit Members from swimming during that time.

We will be having our annual All Members' meeting on the morning of Saturday, July 17, at 9:00 a.m.. We will hold Board elections for the positions of Treasurer, Secretary, and Pool Director, as well review our finances. As always, we look to these meetings for feedback on what's working and what else might add to our Club.
